In recent years, as the information reflected from the Departments of Labor, Invalids and Social Affairs and many organizations and enterprises, the implementation of The Law on Occupational Safety and Health in many foreign organizations, enterprises those are operating in Vietnam have encountered considerable difficulties. One of the important reasons is that the employers and foreign workers have not yet updated the new regulations.
